- ▲ Project Professional Qualification (PPQ)
- ▲ IPMA Level A (Certified Projects Director)
- ▲ IPMA Level B (Certified Senior Project Manager)
- ▲ IPMA Level C (Certified Project Manager)
- ▲ IPMA Level D (Certified Project Management Associate).

CERTIFICATION EXAM

The PRINCE2 7 Practitioner examination will lead to the Practitioner certification. The format of the examination is:

- ▲ Objective testing
- ▲ 70 questions per paper
- ▲ Duration of 150 minutes, including reading time
- ▲ 42 marks (60%) required to pass
- ▲ Open book examination (only the official *PRINCE2® 7 Managing Successful Projects* manual, is allowed).
